Completion of offering in HusCompagniet A/S in connection with directed issue and private placement

HusCompagniet A/S (“HusCompagniet” or the “Company”) has completed its offering of 3,500,000 new shares (the “New Shares”) through an accelerated bookbuilding (the “Offering”).

Further to company announcement no. 12/2023, HusCompagniet has now successfully completed a directed issue and private placement of 3,500,000 New Shares (19.22% of total shares outstanding), at an offer price of DKK 59 per New Share, raising gross proceeds to the Company of approximately DKK 207 million.

“We are very pleased with the strong support received from both existing and new investors in connection with the capital raise. With completion of the capital raise and the refinancing in place with our current financing banks, HusCompagniet has secured liquidity and flexibility to be able to carry out strategic investments and implement commercial initiatives” says Martin Ravn-Nielsen, Group CEO of HusCompagniet, and continues “This provides us with a strong foundation to maintain and improve our leading position in the industry as well as support to our growth going forward”.

The Offering was made pursuant to applicable exemptions from the obligation to publish a prospectus in a directed issue and private placement and subscribed for by eligible institutional and other professional investors in Denmark and in certain other jurisdictions at market price and without pre-emption rights for HusCompagniet's existing shareholders.

Members of HusCompagniet's Board of Directors, Executive Management and senior management have been allocated and will subscribe for a total of 55,083 New Shares as part of the Offering.

HusCompagniet and each of the members of the Board of Directors and the Executive Management have in connection with the Offering agreed to undertake a lock-up commitment for a period of 180 calendar days following settlement of the Offering (subject to certain customary exceptions).

Capital increase

Subject to settlement, a share capital increase will be registered with the Danish Business Authority and the share capital of HusCompagniet will hereafter consist of 21,710,000 shares of nominally DKK 5 each, equivalent to a registered share capital of DKK 108,550,000.

The New Shares represent approximately 19.22% of HusCompagniet's total registered share capital before the capital increase and will account for approximately 16.12% of HusCompagniet's total registered share capital upon completion of the capital increase.

Admission to trading and official listing

The New Shares will be issued under the temporary ISIN code DK0062494506. No application for admission to trading and official listing has been, or will be, filed for the New Shares issued under the temporary ISIN code, and the temporary ISIN code will only be registered with VP Securities A/S (“Euronext Securities Copenhagen”) for subscription of the New Shares. The temporary ISIN code will be merged with the permanent ISIN code for the existing shares (DK0061412855) as soon as possible following registration of the share capital increase with the Danish Business Authority. The New Shares are expected to be admitted to trading and official listing on Nasdaq Copenhagen A/S, in the ISIN code for the existing shares (DK0061412855), on or around 30 May 2023.

The admission to trading and official listing of the New Shares is subject to the Offering not being withdrawn prior to the settlement of the Offering and the Company making an announcement to that effect.

Rights conferred by the New Shares, including voting rights and dividend rights, will apply from the time when the capital increase is registered with the Danish Business Authority. The New Shares must be registered in the name of the holder in the Company’s register of shareholders.
